



## Termite Local Treatment Information

Local or spot control methods include the use of termiticide. Local or spot control also may include the removal and replacement of infested structural wood members. These methods are intended to remove or kill termites only within the specific targeted area, leaving open the possibility of other undetected infestations within the structure. These treatments are NOT designed for whole-house eradication. Local or spot treatment with termiticides involves drilling and injecting termiticide into infested wood member(s).

If you see the following signs in your home, you might have termites:

- sawdust-like droppings
- dirt or mud-like tubes or trails on the structure
- damaged wood members (like window sills)
- swarming winged insects within the structure, especially in the spring or fall

Following the treatment, if any signs of the issues outlined above become evident, please contact your management team. The areas that were treated are covered by a one-year warranty. However, if new signs are discovered in areas not previously treated, a new inspection will be required to assess the situation and provide recommendations from a licensed pest control technician.

Preparation instructions may vary based on the technician's specific recommendations. In most cases, it is not necessary to vacate the premises during treatment. However, the Safety Data Sheet (SDS) should be reviewed beforehand to ensure no adverse effects on the health of occupants.
